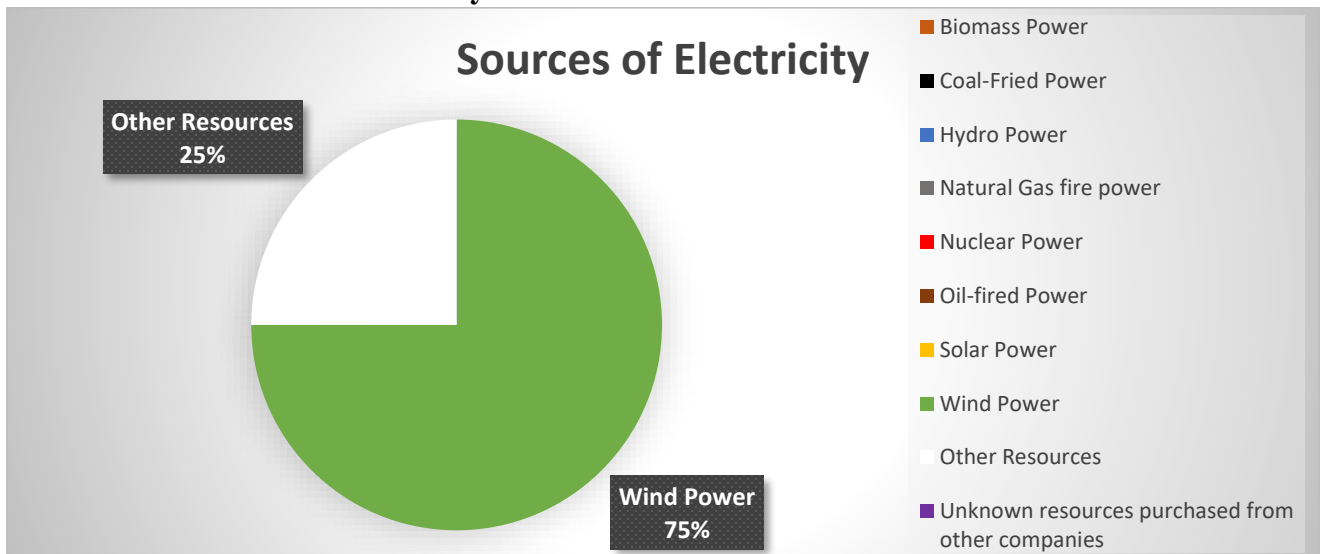

### FOOTNOTE

1. Pure Energy USA IL, LLC will procure and retire renewable energy certificates (RECs) representing the environmental attributes associated with the applicable amount of renewable energy produced from national wind energy generation facilities. You will not have electricity from a specific generation facility however, your purchase ensures that renewable energy equal to 100% of your electricity usage is produced using renewable resources and delivered to the U.S. power grid on an annual basis.

After the close of the calendar year, Pure Energy USA IL, LLC may use the first quarter to reconcile any discrepancies between final usage and renewable energy credits purchased for your electricity usage. In addition to supplying 100% of Renewable Energy Certificates to provide you with renewable energy, Pure Energy USA IL, LLC, as required by law under the Illinois Renewable Portfolio Standard, purchases RECS or makes alternative compliance payments to match 3.625% of customers' actual metered electricity.

2. Carbon dioxide is a greenhouse gas that contributes to climate change. Nitrogen oxides (NOx) contribute to ground-level ozone, or "smog," and sulfur dioxide and NOx contribute to acid rain.

3. 0% of the total electricity supplied was purchased from other suppliers.
